## **CHAPTER 18: ANNEXATIONS**

### **18.0100 MARCH 5, 1985, ANNEXATION OF TERRITORY**

#### **18.0101 DESCRIPTION OF TERRITORY**

In accordance with Section 66.021 of the Wisconsin Statutes, as amended, and the Petition of Electors and Property Owners for Direct Annexation filed with the City Clerk on September 27, 1984, signed by all electors residing in the territory and all the owners of the real property in assessed value in the territory, the following described territory in the Town of Peshtigo, Marinette County, Wisconsin, is hereby annexed to the City of Marinette, Wisconsin:

The Southeast Quarter of the Northeast Quarter (SE 1/4 of NE 1/4) of Section Eleven (11), Township Thirty (30) North, Range Twenty-three (23) East, Town of Peshtigo, Marinette County, Wisconsin.

#### **A. Effective Date**

From and after March 5, 1985, the territory described in Section 18.0101 shall be a part of the City of Marinette for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Marinette.

#### **B. Zoning Classification**

Upon recommendation of the Plan Commission the territory annexed by this resolution is temporarily designated as a "single family" district for zoning purposes and subject to all provisions of City Ordinances relating thereto. The boundaries of the territory described in Section 18.0101 hereof are hereby temporarily established on the official map of the City.

#### **C. Ward Designation**

The territory described in Section 18.0101 is hereby made a part of the Seventh (7th) Ward of the City of Marinette, subject to the ordinances, rules, and regulations of the City governing wards.

### **18.0200 JULY 6, 1993, ANNEXATION OF TERRITORY**

#### **18.0201 Description of Territory**

In accordance with Section 66.021 of the Wisconsin Statutes, as amended, and the Unanimous Approval Petition for Annexation filed with the City Clerk on July 6, 1993, signed by all electors residing in the affected territory and by the owners of all of the real property within such territory, the following described territory in the Town of Peshtigo, Marinette County, Wisconsin, is hereby annexed to the City of Marinette, Wisconsin:

That part of the North-East Quarter of the South-West Quarter (NE 1/4 of SW 1/4) of Section Twelve (12), Township Thirty (30) North, Range Twenty-Three (23) East, described as follows, to-wit: Commencing on the Southeast line of the "Old Marinette-Peshtigo Road" where the North line of said forty-acre tract intersects;

thence Southwest, on said Southeast line One Hundred Eighty-Nine (189) feet, to the Point of Beginning; thence, from said beginning point, continuing Southwest, on said Southeast line, Sixty-Six (66) feet; thence deflecting to the left Seventy-One (71) degrees, Fifty (50) minutes, One Hundred Eighty-Seven (187) feet, thence deflecting to the left Ninety-Two (92) degrees, Fifty-Eight (58) minutes, Seventy-Three and 8/10 (73.8) feet; thence Northwest, in a straight line, Two Hundred Four (204) feet, to the point of beginning; situate in the County of Marinette and State of Wisconsin.

A. Effective Date

From and after July 6, 1993, the territory described in Section 18.0201 shall be a part of the City of Marinette for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Marinette.

B. Zoning Classification

In conformity with the recommendation of the Plan Commission on June 10, 1993, and the Public Hearing held on July 6, 1993 pursuant to Wisconsin Statutes Section 62.23(7)(d)2. and Marinette Municipal Code, the annexed territory is zoned Local Shopping (B-1).

C. Ward Designation

The territory described in Section 18.0201 is hereby made a part of the Seventh (7) Ward of the City of Marinette.

## **18.0300 AUGUST 3, 1995, ANNEXATION OF TERRITORY**

### **18.0301 Description of Territory**

In accordance with Section 66.021 of the Wisconsin Statutes, as amended, and the Unanimous Approval Petition for Annexation filed with the City Clerk on July 7, 1995, signed by all the electors residing in the affected territory and by the owners of all of the real property within such territory, the following described territory in the Town of Peshtigo, Marinette County, Wisconsin, is hereby annexed to the City of Marinette:

The Northeast corner of the intersection of County Highway T and Old Peshtigo Road incorporated by reference is Hugh W. Guy, Jr. Survey Drawing No. 79-114 dated April 15, 1980 containing a metes and bounds description and scale map of the annexed territory.

A. Effective Date

From and after August 3, 1995, the territory described in Section 18.0301 shall be a part of the City of Marinette for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Marinette.

B. Zoning Classification

Upon recommendation of the Plan Commission on July 13, 1995 and pursuant to Wisconsin Statutes Section 66.021(7), the territory annexed is designated as a (B-3) Highway Business District for zoning purposes and subject to all provisions of City ordinances relating hereto. The boundaries of the territory described in Section 18.0301 hereof are hereby established on the official map of the City.

C. Ward Designation

The territory described in Section 18.0301 is hereby made a part of the Seventh (7th) Ward of the City of Marinette.

**18.0400 OCTOBER 3, 1995, ANNEXATION OF TERRITORY**

**18.0401 Description of Territory**

In accordance with Section 66.021 of the Wisconsin Statutes, as amended, and the Unanimous Approval Petition for Annexation dated September 8, 1995 and filed with the City Clerk, signed by all the electors residing in the affected territory and by the owners of all of the real property within such territory, the following described territory in the Town of Peshtigo, Marinette County, Wisconsin, is hereby annexed to the City of Marinette:

The Southwest (SW) corner of the intersection of University Drive and Pierce Avenue/Green Gables Road (formerly Green Gables Tavern).

A. Effective Date

From and after October 3, 1995, the territory described in 18.0401 shall be a part of the City of Marinette and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Marinette.

B. Zoning Classification

Upon recommendation of the Plan Commission on September 14, 1995, and pursuant to Wisconsin Statutes Section 66.021(7). The annexed territory is temporarily zoned as an R-3 Multiple Family Residence District.

C. Ward Designation

The territory described in 18.0401 is hereby made a part of the Third (3rd) Ward of the City of Marinette.

**18.0500 MAY 7, 1996, ANNEXATION OF TERRITORY**

**18.0501 Description of Territory**

The Railhouse Restaurant and Brewery located at W1130 Old Peshtigo Road.

A. Effective Date

From and after May 7, 1996, the territory described in 18.0501 shall be a part of the City of Marinette and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Marinette.

B. Zoning Classification

Upon recommendation of the Plan Commission on April 11, 1996, and pursuant to Wisconsin Statutes Section 66.021(7). The annexed territory is temporarily zoned as a B-1 Local Shopping District.
