Whole number of votes cast in Ward 2 was 64, of which Jeffrey Skorik received 61 for the Office of Alderperson Ward 2


Whole number of votes cast in Ward 5 was 102, of which Wally Hitt received 101 for the Office of Alderperson Ward 5.


